Subject: Hank Raymonds' Conversation with Mr. and Mrs. Spence

About 3:45 or 4:00 p.m. on Monday, May 15, 1978, Hank Raymonds called me to advise that the Spences were in the reception area, having arrived unannounced, and wanting to know what they might be seeing him about. I explained to him as I did last week the two times we talked on Thursday and Friday (the second time was with Jane Randall) when the Spences showed up in his office, that he should talk with them about whatever it is they have on their minds, and that he should provide them with Barney Karpfinger's telephone number so that they can call Barney if they wish. I told Hank I wasn't at all sure what they wanted to speak with him about.

About 4:30 p.m., Hank called me to say that they primarily wanted to know whether or not their son, Wally, had spoken with Coach Karpfinger about transferring from Marquette to the University of Rhode Island. Hank also broached with them the matter of the letter of release from one institution to another, pointing out that technically a coach at Rhode Island should not and could not have talked with Wally prior to having obtained a required (NCAA) release from our Athletic Department here at Marquette. Hank stated that he would have signed such a release had it been requested.

Hank also indicated that they had prepared a financial aid form for Wally for next year, but had never completed it. Wally was not aware of the fact that Coach Karpfinger was looking in that direction (toward financial aid).

I happened to see Hank at the OSA end of the year party about 5:30 p.m. on May 15, and Hank advised that he had called Barney and found that Wally had never talked with Barney about transferring to Rhode Island for wrestling.
